In accordance with part two of paragraph 1 of article 192 of the Entrepreneur Code of the Republic of Kazakhstan dated October 29, 2015, the Government of the Republic of Kazakhstan **HEREBY DECREES:**

1. To approve the attached list of activities carried out by state enterprises, legal entities, more than fifty percent of whose shares (stakes in the authorized capital) owned by the state, and persons affiliated with them (hereinafter referred to as the list of activities).

**Footnote. Clause 1 is as amended by the decree of the Government of the Republic of Kazakhstan dated 16.10.2020 No. 666 (takes effect from the date of its first official publication).**

2. Central and local executive bodies, national managing holdings, national holdings, national companies (upon agreement) until April 1, 2016 to bring to compliance the activities of their subordinate legal entities (in which direct or indirect ownership of shares (stakes in the authorized capital) amounts to more than fifty percent) by exclusion of activities not conforming the approved list of activities from charter documents.

3. Requirement of paragraph 2 of this decree shall not apply to legal entities, more than fifty percent of whose shares (stakes in the authorized capital) owned by the state, and persons affiliated with them, which are subject to privatization and transfer to competitive environment in accordance with decree no. 1141 of the Government of the Republic of Kazakhstan dated December 30, 2015 “On Certain issues of privatization for 2016-2020”.

4. The Agency for the protection and development of competition of the Republic of Kazakhstan (by agreement) annually, by January 5, shall ensure the submission of proposals to the Government of the Republic of Kazakhstan to update the list of types of activities in

accordance with subparagraph 3), paragraph 1 of Article 196 of the Entrepreneurial Code of the Republic of Kazakhstan.

5. This decree shall come into force from the day of its first official publication.
